### OFFICE ORDER

Pursuant to IWAI Board approval, vide Office Order No. No. IWAI-11029/1/2021-ADMIN RECTT-Part(1) dated 3<sup>rd</sup> October, 2024, Shri Mayank Kumar Tyagi, Director (RE) was nominated as the Nodal Officer for execution of transfer related documents with Directorate General of Lighthouses & Lightships (DGLL), and with the Noida Authority (UP) for Sale cum Lease Deed Agreements for the 53 flats acquired by IWAI from DGLL and the process of registration of flats was to be completed 30<sup>th</sup> November, 2024.
