OFFICE MEMORANDUM

Sub:- Implementation of the recommendation of the revision of 6th and 7th Central Pay Commission accepted by Central Government in respect of Fixed Medical Allowances for Pensioners of Inland Waterways Authority of India for those Pensioners who have not opted the medical facilities of IWAI reg.

Authority in the 167th Board Meeting held on 21.12.2017 has resolved to approve the implementation of the recommendation of the 7th Central Pay Commission relating to allowances including special allowances as accepted by the Central Government for employees and Pensioners of Inland Waterways Authority of India as well. Accordingly, Fixed Medical Allowance will be applicable to the Pensioner's who has not opted IWAI Medical facilities are eligible to draw the Fixed Medical Allowance as per the revision of rates of 6th and 7th Pay Commission as per approval of Competent Authority.

1) The admissible rate of Fixed Medical Allowance as per OM.No.4/25/2008-P&PW(D) dated 19th November, 2014 with enhancement of the amount of rate from Rs.300/- to Rs.500/- per month w.e.f 19.11.2014 to 30.06.2017.

Subsequently, on the implementation of 7th Pay Commission revision the admissible rate as per OM.No.4/34/2017-P&PW(D) dated 19th July, 2017 enhanced the admissible Fixed Medical Allowance rate from Rs.500/- to Rs.1000/- per month with effect from 01.07.2017 respectively.

The above prescribed rates of Fixed Medical Allowance are admissible strictly for those pensioner's who have not opted Medical facilities of IWAI.
