Respected Sir,

The Ministry of Environment, Forest and Climate Change has notified the **Environment (Construction and Demolition) Waste Management Rules, 2025** vide G.S.R. 219(E), dated 2nd April 2025, in supersession of the Construction and Demolition (C&D) Waste Management Rules, 2016. The new rules, which will be effective from **1st April 2026**, represent a significant policy shift towards fostering a **circular economy** and ensuring **environmentally sustainable management** of construction and demolition waste.

2. The new rules introduce an integrated and enforceable framework based on Extended Producer Responsibility (EPR), digital monitoring via a centralised online portal, waste utilisation mandates, and well-defined roles and responsibilities for stakeholders, including waste generators, recyclers, contractors, urban local bodies, regulatory institutions and Government agencies.

3. The scientific management of C&D waste is not merely an environmental necessity, it also presents significant opportunities for **resource recovery**, **low-carbon construction**, and **green livelihoods**. Your personal leadership will be pivotal in ensuring the successful and timely roll-out of these Rules.

4. Given the extensive scope and institutional responsibility envisaged under the rules, **all Ministries/Departments, State Governments, Urban Local Bodies, Pollution Control Boards, and allied agencies** are urged to initiate immediate preparatory action for their effective implementation. In particular, the following actions are envisaged to be taken up on priority by concerned Departments/Agencies viz:

1. **Dissemination** of the rules to all relevant departments, including local authorities or development authorities, and field offices for awareness and operational readiness.




2. **Amendment of policies and tendering frameworks** to align with provisions relating to EPR, waste utilisation, and registration.
3. **Identification of sites** for collection points, intermediate storage facilities, and recycling units, including facilitation of infrastructure development.
4. **Capacity building and stakeholder training**, including contractors, service providers, and field-level engineers.
5. **Ensuring registration and data integration** of all relevant stakeholders on the CPCB's online portal.
6. **Timely reporting and monitoring**, as per the responsibilities outlined in the Rules.
7. **Monitoring Committee** to supervise the implementation of these rules in the State or Union territory.

5. I request your personal attention to this matter and seek your support in ensuring time-bound and effective implementation of the 2025 Rules within your jurisdiction. The newly notified rules are enclosed herewith for your kind perusal and reference.
