The land acquisition facilitator will liaison with the Revenue Department to facilitate timely land acquisition and disbursement of compensation according to norms laid down in the RFCTLAR&R 2013.

#### **Key Responsibilities/Duties**

- Undertake joint verification with the state government of the project affected persons and their R&R entitlements. The LA facilitator will verify the information already contained in the RAP and the individual losses of PAPs and validate the same and make/ suggest suitable changes if required.
- The facilitator will be present at all the disbursement camps or during individual disbursement and will record the details of each disbursement made. He/she will support PAPs in completing the required documents for preparation of affidavits and final cheques.
- Assist the PAPs in opening bank accounts, explaining the implications, the rules and the obligations of a joint account and how she/he can access the resources she/he is entitled to, wherever necessary.
- Assist the consultants in relocation of PAFs, ensuring smooth transition and resolving any issues that may come up during the allocation of houses.
- Tracking all disputes on land acquisition referred to the R&R authority established by the State Government. Preparing updates and submitting details of the status of disputes to the PIU/ PMU.
- Preparing and compiling micro plans, monthly reports, updating information pertaining to land acquisition, reports of public consultations and grievances redressed.
- Collect all relevant documentation including gazette notifications, committee approvals and R&R plans from the district administration.
- Participate in any consultation pertaining to land acquisition and preparing minutes of the meeting.
- Updating the PIU/PMU on a monthly basis on the progress of the construction of resettlement colony and support in the formation of resident welfare society for the resettlement colony after its completion.
