TERMS AND CONDITONS OF DEPUTATION

PERIOD OF DEPUTAION 1.

The period of deputation will be 3(three) years from the date of joining in the post subject to curtailment /extension.

PAY & ALLOWANCES 2.

During the period of deputation Candidates will have the option either to get her/his pay in the scale of Rs. 27,400/- to 70,500/- attached to the post of Receiptionist, Paradip Port Trust under the normal rules of the pay attached to the post hold by her/him in her/his parent department, plus deputation (duty allowances in accordance with and subject to the conditions as modified from time to time and such general or special orders issued by the Ministry of Shipping in this regard.

DEARNESS ALLOWANCE 3.

8. PROVIDENT FUND BENEFITS

9. MEDICAL ATTENDANCE & TREATMENT

The deputationist will be entitled to Medical treatment facilities under the rules of Paradip Port Trust.

10. RESIDENTIAL ACCOMMODATION

She/he will be entitled to residential accommodation according to the rules of Paradip Port Trust, when residential accommodation is provided by the Paradip Port Trust, she/he will have to pay rent, plus additional charges for water and Electricity etc., as per the rules of Paradip Port Trust.

11. CHILDREN'S EDUCATIONAL ALLOWANCE & REIMBURSEMENT OF TUITION FEE
