The previous roster maintained was in a running roster format. The same has been converted as per instructions issued by DoPT vide order dated 02.07.1997 as per authorised strength of Direct Recruitment as per IWAI RR. The relative seniority of the candidates recruited in same panel shall be determined as per order of merit in which they are selected. Also, the previous unsigned/distorted roster was maintained as 50% by promotion and 50% by Direct Recruitment whereas initial RR stipulated 50% by promotion and 50% by transfer on deputation/transfer-failing which by Direct Recruitment. Also, the RR amended in 2015 stipulated 75% by promotion and 25% by Direct Recruitment and also the cadre strength was increased from 9 to 13 vide MoS Order dated 07/09/2016, The roster had to be drawn afresh. The roster has been corrected keeping the name of the employee already holding DR post. The previous distorted roster stands nullified and superseded.
