CIRCULAR

It is intimated that the revised guidelines for Home Isolation of Ministry of Health & Family Welfare, Govt. of India, for Home Isolation of mild / asymptomatic COVID -19 cases dated 5th January, 2022 are as follows –

*“Patient under home isolation will stand discharged and end isolation after at least 7 days have passed from testing positive and no fever for 3 successive days and they shall continue wearing masks. **There is no need for re-testing after the home isolation period is over.***

Asymptomatic contacts of infected individuals need not undergo Covid test & monitor health in home quarantine”.

2. All the IWAI officials infected with the COVID-19 will be regulated as per the revised guidelines of Ministry of Health & Family Welfare dated 5th Jan, 2022.
3. Personnel have to be mandatory get RTPCR test as applicable as per the MoH&FW guidelines and Nodal Officer COVID-19 letter dated 14.01.2022 and leave request to be submitted along with RTPCR test.
