- (iii) 3 years' experience in a supervisory capacity in commercial accounts in the Finance or Accounts Deptt. Of the Central/State Govt. or Semi-Govt. organization or a commercial organization of repute.
- (iv) Desirable: Degree/Diploma in Business Management
