Subject: Notification of 'Customs Area' at Kolaghat Port- Regarding.

1. The Central Board of Indirect Taxes and Customs vide Notification No. 111/2020(N.T.) dated 11.12.2020 has amended the notification No. 63/1994-Customs (N.T.) dated 21.11.1994, under Section 7 of the Customs Act, 1962, by notifying Kolaghat Port in Purba Medinipur district, West Bengal, through the river route as per the Protocol on Inland Water Transit and Trade between India and Bangladesh connecting Kolaghat Port in India to Bangladesh.
2. In exercise of the power vested in me under Section 8 (a) of the Customs Act, 1962, I, Shri Rajesh Jindal, Principal Commissioner of Customs (Preventive), Kolkata, do hereby notify 'Customs Area', as described in Schedule below, at Kolaghat Port, for the purpose of loading of goods for export to Bangladesh through the river route as per the Protocol on Inland Water Transit and Trade between India and Bangladesh connecting Kolaghat Port in India to Bangladesh.
