PUBLIC NOTICE: 15/2019

Sub: Customs formalities at Bandel (BTPS), Kolaghat (KTPS), Pakur (for stone) and Farraka Barrage (NTPC) - Reg

Attention of all Exporters/Importers, Customs Brokers, Members of Trade and other stake-holders is invited to the Customs formalities, which will be followed at Bandel (BTPS), Kolaghat (KTPS), and Farraka (NTPC) Jetties for export of stone and Fly Ash to Bangladesh through the Riverine Protocol Route.

- 2. The Customs Officers of Dhuliyan Preventive Unit shall supervise the loading of the export goods in the barges viz stone & Fly Ash, as the case may be, from Pakur Jetty at Putimari in Murshidabad District and RCC Jetty & Terminal Ghat Jetty near the downstream Lock Gate of the Farakka Barrage in Murshidabad District of West Bengal. The report of the loading supervision of the goods shall be certified in the prescribed Form (Annexure A).
- For Bandel Jetty located at BTPS Tribeni in Hooghly District and Kolaghat Jetty placed at Kolaghat in East Midnapur District, loading of Fly Ash in the Barges/Vessels shall be done under the supervision of Customs officers of T. T. Shed LCS.
- 4. After arrival of the Barges/Vessels from the above Jetties at T. T. Shed LCS, Bills of Export will be filed at T. T. Shed LCS in EDI system and assessment, examination & Let Export Order will be done by the officers of T. T. Shed LCS. In this regard the procedure prescribed in Public Notice No 03/2019 dated 20.03.2019 shall be followed.
- 5. Thereafter, the Cross Border Certificate will be given by the Customs Officers of Hemnagar LCS on the basis of the LEO given by the T. T. Shed LCS officers.
- 6. Only Indian Barges/Vesseis are allowed to load export goods from the above mentioned locations as it is beyond the Riverine Protocol Route. This procedure is permitted for exports under Free Shipping Bills only.
- Difficulty, if any faced in implementation of this Public Notice may be brought to the notice of the undersigned.
