Sir,

1. With reference to above, the competent Authority is pleased to award the work order for deployment of Unarmed Security Guards at IWAI, Head Office for the period from Mar 2022 to Feb 2023 at a total cost of Rs 51,955,60.00 (Rupees fifty one lakh ninety five thousand five hundred and sixty only) excluding GST as applicable. The Bill of Quantity to be executed and the rates are enclosed as Annex-A.

2. The period of work shall be from 01.03.2022 to 28.02.2023.

3. The quoted percentage of service charge shall remain unchanged i.e 5.01%. However, minimum wages of the deployed manpower as prefixed in the BOQ may undergo changes depending upon the Minimum wages revised by Chief Labour Commissioner (CLC) New Delhi. The payment will be made only for the quantity actually executed and certified at the rates indicated against each item of schedule of Quantities & Rates enclosed as Annex - 1.

4. You are required to deposit performance security of Rs. 155867/ (Rupees one lakh fifty five thousand eight hundred and sixty seven only) i.e. 3% (three percent) of the contract value within 15 days from the date of issue of this letter in the form of either demand draft in favour of IWAI Fund payable at Noida / Delhi issued by any nationalized/schedule bank or through RTGS/NEFT or in form of Bank Guarantee issued by nationalized/schedule bank as per Rule 171 of GFR 2017. The performance security, if submitted through B. G. shall be initially valid up to 15.04.2023. This bank guarantee shall be extended and kept valid till the final completion period as per terms and conditions of the contract.



The firm has to ensure monthly payment of wages directly to the bank account of the workers deployed at IWAI, by RTGS/NEFT etc. and also remit EPF & ESI contribution of the employer to the EPFO & ESI etc. as per due date every month. Documentary proof of above payment has to be produced along with the bill for the next month. Failure to do so may result in cancellation of the contract and imposition of penalty, forfeiture of security/ performance security etc.

6. The Contractor shall provide for a substitute when the absence exceeds 2 days or even earlier, if situation so warrants. Any laxity in the matter shall invite a penalty of Rs.500/- per day subject to maximum of 10% of contract value apart from deduction of salary on pro rata basis.

The price bids of technically qualified 14 bidders including you have been opened online on 21.08.2019. After evaluation of price bids of all bidders it was found that 5 bids have the same minimum/lowest rates with highest & equal marks obtained based on their documents. Therefore, the Competent Authority in IWAI has decided that the allotment of the tender shall be made through draw of lots between 5 of the lowest bidders. The draw of lots has been conducted on 24th of October, 2019 at 16.00 hours (4.00 pm). The lots of chits have been picked-up by a neutral person and draw has been gone in your favor.

Therefore, your item rate tender for providing "Security Services" for premises of IWAI office cum R & D complex at A-13, Sector -1, Noida has been accepted through draw of lots and as per your quoted rates Rs. 32,62,284.00 (Rupees thirty two lakh sixty two thousand two hundred eighty four only) including GST & service charge for one year (12 months x 271857/-) per annum. The payment will be made only for the quantity actually deployed and certified at the rates indicated against each item of schedule of Quantities & Rates enclosed as Annex - 1.


