User Charges

Section 17(1) of IWAI Act, 1985 mandates levy and collection of fees and charges by IWAI for use of the national waterways for the purposes of shipping, navigation, infrastructural facilities among others.

IWAI shall levy a consolidated fee from 2010-11 from River Cruise operators for providing aforementioned services. Details of the fee to be levied will be decided after consultations with all stakeholders.

Memorandum of Understanding (MoU)

IWAI has, so far, signed Memorandum of Understanding (MoU) with M/s Pandaw Cruises India Pvt. Ltd. on 30th April, 2009 and with Banaras House Private Ltd. on 12th June, 2009 for promotion of river tourism through river cruising M/s Pandaw Cruises India Pvt. Ltd. has already commenced River Cruise service between Kolkata and Varanasi.

M/s Banaras House Pvt. Ltd. intends to start their operations between Varanasi and Allahabad by hovercraft shortly.


IWAI is ready to enter into MoU with other River Cruise operators and detailed Guidelines in this regard will be issued shortly.

Future Trends

River Cruise on Ganga and Brahmaputra is still in its infancy. There is huge untapped potential as there are few rivers in the world which can match the sights on view on Ganga and Brahmaputra! So is the case with West Coast Canal in Kerala.

They have the potential to be developed into Great River Cruises of the world matching and then surpassing those on offer on River Nile, Egypt, River Yangtse, China, River Amazon, Brazil, River Rhine, Germany, River Danube, Europe, River Volga, Russia and River Irrawaddy, Burma.

If tourists can see the sights of both Ganga and Brahmaputra on one river cruise, then that would be the perfect icing on the cake. That eventuality can materialize only when Protocol on Inland Water Transit and Trade between India and Bangladesh is extended to cover long distance River Cruise and the validity of the Protocol is extended for a longer period. At present, the Indo-Bangladesh Protocol is extended for two years at a time and is currently valid till March 2011.

So, in this regard it is worthwhile to mention that much more improvement of the facilities in the form laying of pontoon jetties at Chundannagur, Bandel, Pallassey etc in NW-1 and at Bally island, Chottamollabkhali at Sunderban area along with the passengers' waiting room, beautification of the terminal area are needed to be done as compared to the standard of the western countries. Similarly, for the cargo movement strengthening of terminals with necessary infrastructure for efficient loading/unleading at the shortest possible time should also be arranged.

In addition, the whole river stretches of declared National Waterways should be divided into small stretches along with necessary infrastructure like dredger, tag etc. for attending the vessels moving in the particular stretch on emergency. We are sure that over a period of time these facilities will be made available to all the vessels operators and suitable charges for utilization of the facilities once fully created, can also be levied in consultation with the operators.

We once again assure you our best co-operation in your endeavor for making declared. National Waterways fully navigable along with the infrastructure so that the same can be compared with the waterways of the western countries.
