5. Technical credentials shall be in the form of similar work performed for Government/PSU with work order & bidder infrastructure facilities

6. Financial Credentials shall be in the form of 03 years Annual turnover, IT Return, valid PAN & Bank account details
7. Acceptance to IWAI Payment terms and condition
8. The payment shall be released in following two stages within 30 days duly certified by the Field Director:
 - a. 90% of cost of software shall be released on supply and successful installation of software.
 - b. 10% of cost of software shall be released on submission of BG of equivalent amount with validity beyond 60 days of warranty period with two day demonstration at Patna office.
9. No cost for annual subscription & No update is required after warranty period.
