

2.	Part – V, 7. Schedule of quantities (Price bid), s.l.no: 3, page no: 83	Is accommodation for crew is provided in the tender?	-do-	Rates for the accommodation may be quoted by bidders and charges will be reimbursed on submission of rent receipt / proof for the same.
3.	Part – V, 7. Schedule of quantities (Price bid), s.l.no: 4, page no: 83	Is provision of conveyance for crew is provided in the tender?	M/s Nautilus Shipping India Pvt Ltd, Chennai	Rates for the conveyance charges may be quoted by bidders and same will be reimbursed on submission of receipts / proof for the same.


