TERMS & CONDITIONS

- 1. The rate quoted should be including of all the costs such as cost of equipment, installation & Commissioning charges on the vessels of respective waterways, taxes, transportation, etc. No other extra charges will be entertained.
- 2. The equipment shall be supplied and installed within eight weeks from the date of issuance of supply order and approval of the sample piece at Head Office. The exact location of the supply and installation shall be intimated after the approval of the sample piece.
- 3. 90% Payment will be made by cheque or through RTGS within fifteen days from date of receipt of the bill as well as installation of equipment's and certification of the bill by the officer concerned after deducting the statutory dues, if any. The balance 10% shall be released on completion of satisfactory of warranty period i.e one year from the date of installation and duly certification by the officer concerned.
- 4. The equipment shall stand guaranteed for one year from the date of installation or as per the manufacturer, whichever is later against the material, workmanship etc.
- 5. In case of delay in supply, liquidated damage @1% per week subject to a maximum of 5% of the final contract price will be charged.
- 6. The documents such as authorized dealer certificate / stockiest/ manufacturer as well as ISO 9001: 2008 certificate, registration certificate of the company, credential for similar supply of at least value of more than Rs 50,000/- in any Govt., PSU and Autonomous bodies are to be submitted alongwith the quotation.
- 7. The bidder must have experiences in installing of similar attendance system on marine vessels such as GPRS facility supported.
