Expression of Interest

- Inland Waterways Authority of India (IWAI), Ministry of Shipping, Government of India has applied for financing from the World Bank towards the cost of the Project "Capacity Augmentation of the National Waterway –1 (Jal Marg Vikas Project)", and intends to apply part of the proceeds for consulting services.
- The consulting services ("the Services") include **Consultancy Services for Study on the effect of navigational activities on Dolphin in the National Waterway -1.** This study is aimed at assessment of risk associated with navigational activities on aquatic biodiversity and Gangetic dolphin.

The scope of the study includes:

- **a)** Literature review of reports of Gangetic Dolphins within National Waterway-1 providing a summary of the findings and recommendations.
- **b)** Identification of breeding grounds and populated site(s), good habitats for Dolphins in NW-1 stretch based on primary surveys and consultations with relevant communities and stakeholders.
- c) Identification and marking of suitable habitats from habitat suitability models. d) Identify risks and impacts due to navigational activities in breeding grounds and populated sites of Dolphins due navigation
- e) Impact of increase human activity within key dolphin habitats should also be studied, as NW1 operations will support ferry boats and tourism activities, and key preventative measures for advoiding and reducing impacts on dolphins should be provided.
- **f**) Preparation of Environmental/Aquatic wildlife Management Plan for mitigating impacts from navigational activities with due emphasis on various life history parameters of dolphin such as breeding and feeding.
- **g**) Development of suitable plans and specific mitigation measures in the case of risks assessed to dolphin from the impacts of rive traffic, accidental contamination and spills, collisions and injury caused by collisions.
- **h)** Development of a monitoring programme to adaptively manage existing EMP and study recommendations, by use of appropriate performance indicators.
- i) Examine the existing policy framework and need of wildlife clearances for navigation in NW-1 and provide technical assistance and coordination for the obtaining such clearances.
- 3. The Project Director, Project Management Unit, IWAI, invites eligible consulting firms ("Consultants") to submit their interest to provide Consultancy services for "Consultancy Services for Study on the effect of navigational activities on Dolphin in the National Waterway –1". Consultants interested in providing the Service should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. Consultants may associate with other firms in the form of a joint venture or a sub-

consultancy to enhance their qualifications. The short-listing criteria are:

- a) Consultant should be engaged in conducting similar activities for the past 5 years copy of Certificate of Incorporation to be submitted along with the EOI.
- b) Consultant should have a minimum financial turnover of INR 0.50 Crore during any of the last 5 years CA certified declaration for last 5 years to be submitted along with the EOI.
- c) Consultant should have completed 2 such studies of similar / related work during the last 5 years List of scope of work, date of commencement, date of completion, client's details to be submitted along with Client's Certificate of successful completion of task.
- d) Consultant should be having a minimum of 15 employees on their payroll declaration to be submitted.
- e) Notarized copy of Power of Attorney of the signatory/ies signing the EoI and/or associating to submit the EoI to be submitted.
- f) In case of EoI submission as Joint Venture, notarized copy of JV to be submitted.
- 5. Expressions of interest must be submitted on CPP Portal of GoI by 17th April, 2017 by 15:00 hours (IST) and it shall be clearly marked "Expression of interest for Consultancy services for "Consultancy Services for Study on the effect of navigational activities on Dolphin in the National Waterway -1"
- 6. The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's *Guidelines: Selection and Employment of Consultants under IBRD Loans and IDA Credits & Grants by World Bank Borrowers* dated January, 2011 ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.
- 7. A Firm or an individual Debarred by the World Bank in accordance with the anticorruption guidelines shall be ineligible for this Assignment in any form or way. A list of debarred firms and individuals is available at the Banks external website: www.worldbank.org/debarr.
- 8. A Consultant will be selected in accordance with the Quality and Cost Based Selection method set out in the Consultant Guidelines.
- 9. Further information can be obtained at the address mentioned above during office hours.

Instructions for submission of Expression of Interest:

- 1. Accomplished Expression of Interest (Application) must be submitted together with a Letter of Intent not later than 15:00 hours (IST) on 17th April, 2017. Documents in support of all qualification information shall be submitted with application. Proposal of EOI with qualification information shall be furnished on / before the due date of submission on CPP Portal.
- 2. The Application shall be basis of drawing up a shortlist of eligible Consultants who will be invited to submit proposal for services required.
- 3. All Applications shall be submitted in English.
- 4. A Consultant shall submit only one proposal. If a Consultant submits or participates in more than one proposal, all such proposals shall be disqualified. This does not, however, preclude a consulting firm to participate as a sub-consultant, or an individual to participate as a team member, in more than one proposal when circumstances justify and if permitted by the Request for Proposals.
- 5. The Application and all related correspondence and documents should be written in the English language. Supporting documents and printed literature furnished by Applicant with the Application may be in any other language provided that they are accompanied with translations in the English language. Supporting materials, which are not translated into English, may not be considered. For the purpose of interpretation and evaluation of the Application, the English language translation shall prevail.
- 6. IWAI reserves the right to reject any Applications, without assigning any reasons thereof.
- 7. The Applicant shall provide all the information sought under this Qualification Document. PMU, IWAI would evaluate only those Applications that are received within the specified time and complete in all respects. Incomplete and/or conditional Applications shall be liable to rejection.
