CORRIGENDUM – 3

Corrigendum on Tender document for "Design, Construction, Supply, Transportation, Installation, Testing and Commissioning of Steel Pontoons and Gangways using suitable steel enveloped HDPE / FRP floating material for providing Floating Terminal facilities at various locations on NW – 1 (Ganga – Bhagirathi – Hooghly river system from Haldia to Varanasi) & NW – 2 (Brahmaputra river)"

The following clauses of the tender document are hereby modified to be read as follows:

1. The last date & time of Bid submission and opening of Bid / Tender are hereby extended as hereunder:

2. Clause 16.1.1, Qualification Criteria, Section II: ITB (except the notes mentioned in th e said clause) is hereby modified to be read as follows:

"Qualification Criteria for Works

The Bidder should have successfully completed "Similar Works" in previous seven (7) years before the last date of the Bid submission as per the criteria specified below:

- a. 3 similar works each costing not less than the amount equal to 40% of the estimated cost put t o this tender of respective Schedule, or
- b. 2 similar works each costing not less than the amount equal to 60% of the estimated cost put t o this tender of respective Schedule, or
- c. 1 similar work costing not less than the amount equal to 80% of the estimated cost put to this tender of respective Schedule

For this purpose, **"Similar Works**" means "execution of onshore/offshore structures including fabrication of steel pontoon/HDPE gangway

3. Replace the contents of clause 1.3.2 of Part II: Technical Specifications, Section VI: Terms of Reference with the following:

Electrically operated anchor windlass of required size to be installed on both sides shall be provided for the handling of anchors of 600kg each. Two numbers of hand operated davits of 1.5-ton SWL each to be provided conforming to IS 5386 (1969). The anchor windlass shall have one chain pulley / sprocket and one warping head. Lined brakes and couplings to be provided for independent operation of the pulley and the warping head.
