1.	Is Joint Venture permitted with specialised firms?	 The bidder has to submit documentary proof of "intent of forming JV" on Rs.100/- notorized stamp paper at the time of submission of bid, However, successful bidder is required to submit proof of registration of JV before award of work. The bidder should be the lead partner of JV and the financial turnover of only the lead partner would be considered for evaluation. JV with not more than two firm is allowed. Bidder has to provide work award copy, work completion certificate indicating date of commencement, date of completion, value of work executed by the bidder for each works forwhich the bidder is claiming as work for the above experience. However, The responsibility of O&M contract would be with the bidder only.
