NOTICE INVITING E-TENDER

The Inland Waterways Authority of India (IWAI) hereby invites online tenders/bids (Technical and Financial Bid) from experienced & reputed National and International Manufacturers for supply of two Cranes of proven design and standard type/model with satisfactory performance for installation on board Pontoon for providing Temporary Terminal facility at Erada on NW 5, Odisha as per details given below. Supply of two Cranes of proven design and standard model having satisfactory performance as per the following technical parameters: Design, construction and supply of two Cranes of Diesel Hydraulic Material Handling Machine mounted on pontoon, capable of loading bulk cargo like coal granular, coking coal, ores such as chrome, lime, scrap steel, S S Plates. etc. from vessels to stack yard on shore and vice versa using various lifting equipment like hook, Clamshell grab buckets, orange peel buckets etc. No rope controlled grab operation shall be accepted including the cost of shipping, road transportation, custom duty & other local taxes etc. for final delivery at Erada in Jajpur District of Odisha.	550 lakhs	11 lakhs	20 Weeks

Applicant submitting the online bids would need to pay the cost of tender document/bid along with the application non-refundable demand draft for Rs.2000/- drawn in favor of “IWAI FUND” payable at NOIDA/Delhi.

2. Eligibility Criteria :

The eligibility criteria for the participation in the tender for above work shall be as follows:

- (i) This invitation of bids is open to all bidders **indigenous or internationally** reputed firms engaged in design, construction and supply of Cranes of similar types having standard and proven design and model/type which are operating with satisfactory performance over a period of two years.
 - (ii) The international (foreign) firm/company engaged on the design, construction and supply of the standard and proven design with satisfactory performance may participate directly or through their authorised agencies/suppliers in India.
 - (iii) Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices by the Central Government, the State Government or any Public undertaking, Autonomous Body, Authority by whatever name called under the Central or the State Government.
 - (iv) The bidder must have at least seven years' experience and satisfactory performance record for the design, construction and supply of Cranes of similar type or higher size/capacity.
3. Tender must be accompanied with scanned copy of all documentary evidence of credentials viz. similar works done, performance certificate, financial performance and all other documents as specified in the tender document.
 4. The Earnest Money as in Clause 17 of ITB (Information to Bidders) in the form of Demand Draft for 50% of the amount and balance 50% through B.G. (Bank Guarantee) are to be deposited from Scheduled Bank of India or National Bank of the Foreign Bidders along with the bid. The original demand draft and B.G. for tender fee and EMD must be deposited before closing date and time of submission of bid at IWAI, A-13, Sector-1, NOIDA-201301.

5. The firm should have average annual financial turnover during the last three years ending 31st March of the previous financial year of at least Rs. 550.00 lakhs (100% of the estimated cost).
6. The firm should have experience of having successfully completed similar works during last seven years ending last day of the month previous to the one in which bids are invited, either of the following:
 - a) Three similar completed works costing not less than Rs. 220 lakhs (40% of estimated cost)
 - b) Two similar completed works costing not less than Rs. 330 lakhs (60% of estimated cost)
 - c) One similar completed work costing not less than Rs. 440 lakhs (80% of estimated cost)

Similar works shall be design, construction & supply of cranes of proven design & standard model with good performance for the cranes of different types, size & capacity for installing on board the sea going/inland vessels, ports & harbours and other intermodal use.

7. The pre bid meeting will be held on 14/05/2015 at 15:00 hrs in IWAI Office at Noida.
8. The complete bid as per the tender documents should be placed online at <https://eprocure.gov.in/eprocure/app> by 1700 hours on 27.05.2015. The technical bids would be online opened on 29.05.2015 at 1430 hours in the presence of the representatives of the bidders, if any.
