The Inland Waterways Authority of India (IWAI) hereby invites tenders from experienced firms/agency for supply and commissioning of **one Amphibian Dredger** built either indigenously or imported to be delivered at Kochi immediately with an option of procuring two more on the same price, terms & conditions either together or individually depending on operational requirements of various National waterways within nine months of the delivery & commissioning of the first dredger as per details given below:-

A signed declaration stating that no alteration has been made in any form in the downloaded tender document is to be enclosed with the tender by the bidder for downloaded tenders. 2. The bids must be submitted preferably in hard bound form with page numbering and proper indexing.
3. The firm should have a minimum annual turn over Rs. 3.00 crors in 3 years during last 5 years.
4. The firm should have supplied similar type of dredger during last 3 years with the proof of their satisfactory performance from the client.
