Page no 15 of 113 paragraph three, cluster-VIII defines the minimum eligibility criteria the bidder needs to meet in order to be eligible for technical evaluation. The bidder shall be eligible if it meets any one of the listed criteria

- (i) Three similar works **each** costing not less than Rs. 2.5 Cr; **or**
- (ii) Two similar works **each** costing not less than Rs. 3.7 Cr.; **or**
- (iii)One similar work costing not less than Rs. 4.9 Cr.

As per Page No. 19 of 113, clause 26.4.1-subcriteria, SL No 3,

Once the bidder is eligible, meeting any one of the criteria stated above, it can score full marks, i.e., 15 marks, including projects used to meet the minimum qualification criteria. Bidder shall submit completion certificates for such projects on client letter head. The certificates should clearly mention the start date & end date of the project, value of services provided by the bidder and percentage share of the firm in case the work was performed in JV. All projects submitted shall be of "similar nature" as stated below:

"Specific experience of the Consultant in preparation of detail project reports / techno economic feasibility study / Hydrographic Survey for development of navigation channel including river training works and construction of Ports, river terminals, riverine structure, IWT terminals, logistics hub, Canal development, reservoir desilting, river survey and other water resource sector".

It may be read as Service Tax @ 14.5%.
