Sealed quotations are invited from the experience/reputed firms at Patna as per the annexure enclosed herewith on the following terms & conditions.

Terms and conditions: -

- 1. The price rate may be quoted in both words and figures.
- 2. The firm/agency shall be registered with the concerned department and having registration certificate with GST, ESI, EPF and the scan copy of the same may be submitted by the tender along with online bid.
- 3. The firm/agency shall pay to labourer employed by him either directly or through sub-contractors wages not less than wages as defined in Minimum Wages Act 1948 and Contract Labour (Regulation and Abolition) Act 1970 amended from time to time and rules framed there under and other labour laws affecting contract labour that may be brought in force from time to time.
- 4. The rate as quoted shall be evaluated for number of labourer mentioned in the NIQ per days with one boat including boatmen per month. The firm shall provide additional number of labours as and when required in addition to NIQ quantity.
- 5. The firm/agency shall not employ any person who has not completed 18 years of age, the minimum age specified in Indian Labour law.

- For hiring of 01 nos Mechanised Boat with a Boatman and 04 nos unskilled labourer for assisting the dredging work by the dredging Unit at various dredging site between Rajmahal to Gazipur in NW-1.
- 7. The supply of labourers and Mechanised Boat will be completed within 10 days from the date of receipt of work order. The numbers of labours and their deployment date shall be intimated separately the requirement of dredging site. Condition of boats will be inspected by the EIC and labours should be fit for work.
- 8. The payment shall be made monthly through RTGS within 15 days from the date of production of bill and muster rolls/attendance duly certified by the officer concerned.
- 9. All labourer should know the swimming.
- Any causality/disability and accident of the boat and men power will be responsibility of the contractor during the contract period.
