Sealed quotations are invited from the reputed Contractor/ repairer/ authorized dealer for the repair of IWAI Vessel AB Dhawalgiri at Rupnarayan River NW-86 as per annexure & terms and conditions laid down below. The NIQ can also be downloaded from IWAI's website (www.iwai.nic.in).

- (2)The repair work should be done as per following terms and conditions mentioned below:
- (i) The price may be quoted in both percentage and figures in annexure.
- The price should be quoted inclusive of labour charges, loading-unloading and (ii)cost spares etc. The cost of spares will be paid on actual + 10% basis, subject to the spares being fitted and supplied within the estimated cost. Any incremental spare costs must be prior approved by the Competent Authority. No additional charges will be entertained. GST will be extra as applicable.
- The repair work must be completed within 10 days from the date of receipt of (iii) order from R.O. Kolkata.
- (iv) The firm must submit documentary evidence, including a copy of the Trade License, PAN, GST details, bank details (a copy of a cancelled cheque), and proof of similar work experience valued at least 100% of the project scope.
- The payment will be made by RTGS within 15 days from the date of successful (v) completion of work and certification of the bill by the officer concerned duly deducting statutory dues.
- In case of delay in completion of work liquidity damage @ 0.5% per week (vi) subject to a maximum of 10% will be charged.
