Subject: NIQ for Annual/afloat repair of Anchor Pontoon-IV for F.Y.2022-23-reg.

Inland waterways authority of India (IWAI) invites quotations from reputed repairer/contractor for Annual/afloat repair of Anchor Pontoon-IV for F.Y.2022-23. Details of BOQ are enclosed as Annexure-I. The terms and conditions are as under:-

- 1. The estimated cost for the job is Rs. 1,28000.00 (Labour Charges= Rs.87900.00, Tentative cost of spare on actual plus 10% basis= 40100.00 excluding GST).
- 2. The quoted price shall be excluding GST as per applicable and cost of spare on actual plus 10% basis, transportation charges, man & materials etc. No other claim will be entertain.
- 3. The repairer shall have past experience of similar work and submit the copy of the same duly signed and stamped.
- 4. Repairer shall be registered with GST and submit photocopy of PAN card & GST issued by the concerned department and submit copy of valid registration certificate.
- 5. The repairer shall be submit Bank detail & cancelled cheque.
- 6. The work shall be completed for within 30 (thirty) days from the date of receipt of work order as per directive of EIC.
- 7. In case of delay in completion of the above repairing work and delivery, liquidated damages will be applicable @ 1.0% per week subject to a maximum 10% on the total value of the contract.
- 8. The 10% amount of the total work order value will be withheld/deducted from your bill and same will be returned after completion of warranted period of 06 months and 90% payment of the total work order value will be paid within 15 days after completion accordingly scope of work and acceptance of final bill/invoice. The bill shall be submitted with related documents.
- 9. IWAI reserve the right to accept or cancel any quotation without assigning any reason or any prior notice.
- 10. The repairer/contractor shall submit the BOQ (Annex-I) after duly stamp and signature.
