

TERMS & CONDITIONS


1. The price may be quoted including all the costs such as labour, taxes, materials, transportation etc except GST which shall be reimbursed only after submission of proof of its remittance.
2. The construction/erection work shall be completed at, Matiary within 10 (Ten) days from the date of receipt of the work order and the same shall be maintained upto 06 (six) months from the date of completion & as per direction of E.I.C or his representative.
3. 90% payment shall be released by RTGS within 15 days from the date of submission of bill and duly certification of the bill by the officer concerned after deduction of the statutory dues if any. Balance 10% will be released after completion of guarantee obligation period of 12 month on duly certification of the officer concerned.
4. In case of delay in completion of works, liquidated damage @1.5% per day computed on daily basis subject to a maximum of 10% will be charged.
5. The firm should also require submitting self certified copy of PAN Card, Registration certificate, GST, and credential certificate etc.
