 - The price should be quoted inclusive of all costs, including equipment, (ii) manpower, materials, etc. The cost of spares will be paid on actual + 10% basis, subject to the spares being fitted and supplied within the estimated cost. Any incremental spare costs must be prior approved by the Competent Authority. No additional charges will be entertained. GST will be extra as applicable.
 - The supplied spare parts should be reputed brand/ISI certified & the (iii) copy of purchase bill should be submitted along with the bill of firm cost of spares will be reimbursed on actual basis.
 - The repair work must be completed within 03 days from the date of (iv) receipt of order from R.O. Kolkata.
 - The firm has to submit documentary evidence of current copy of the (\mathbf{v}) Registration Certificate, PAN, GST and Experience with similar work.
 - 90% payment will be release on completion of work. Remaining 10% (vi) will be released after completion of guarantee/warrantee period of six months.
