Reference above, we acknowledge your request for clarification on the following queries.

Sl. No.	Queries raised by M/s CK Infrastructures Ltd	Response to queries by IWAI
1	As per EOI "Construction at IWAI land premises in Assam under PPP mode" where the estimated cost of work is Rs. 65.36 cr but in case if any bidder wants to execute any one work, the tender cost would be Rs. 65.36 cr or estimated cost given in the EOI. For example, if we want to execute only "Construction at Additional IWAI Pandu (Plot-A) Land premises (near temple) under PPP mode". (incl. Furnishing Work) then the total estimated cost will be Rs. 13.26 cr or Rs. 65.36 cr and technical and financial capacity will be calculated on Rs. 65.36 cr or Rs. 13.26 cr?	Reference Clause d) "Scope of Work" of the NIT in the Tender document, "The bidders may submit for all schedules or any of the schedules. The Solvency, Qualification criteria etc. shall be applicable accordingly. The bidder may show their interest for one (or) more IWAI land premises for execution of construction work.". Citing your given example, the total estimated costs for bidding for Plot-A only shall be Rs. 13.26 cr and not Rs. 65.36 cr.
2	Technical Capacity: - As this is PPP Project similar experience should be considered under technical capacity. Any bidder who has completed PPP projects only may be considered under technical category. So that in public interest experienced bidder may execute the work.	Refer Pre bid clarification under Sl. No. 6, uploaded in the government eprocure website & IWAI website. "It is not compulsory to have previously completed any project under PPP mode, however more weightage will be given to the party if they have previously completed projects under PPP mode as mentioned clearly in Clause 3.17 Sl. No (d)"
