- 2. The Employer may, without prejudice to any other method of recovery, withheld / deduct the amount of such damages from any money due or to become due to the Contractor. The amount withheld or deducted against such damages shall not relieve the Contractor from his obligation to complete the Works, or from any other of his obligations and liabilities under the Contract.
