## **NOTICE INVITING QUOTATION**

Sealed quotations are hereby invited from the contractors/agencies for supply of a mechanized country boat at Haldia Dredging Site for providing day to day assistance (24 x 7 basis) to CSD Shipra as per terms & conditions given below. The details of the work and B.O.Q are enclosed as Annexure -A with this N.I.Q. which is to be filled in and submitted along with a forwarding letter addressed to **Director, IWAI, P-78, Garden Reach, Kolkata-700 043.**

Sealed quotations will be received up to 3:00PM on at 10.10.2024 and will be opened on same day at 4:00PM. The contractors/agencies or their authorised representatives (with authorisation letter) who have submitted the quotations may also be present during opening of same by the committee members of R O Kolkata.

Rates should be quoted inclusive of all charges but excluding GST. The rates shall be quoted legibly both in figures and words and shall be valid up to 31 March 2025 from the date of opening. The name of the work should be clearly written on the sealed envelope.

I.W.A.I. reserves the right to accept or reject any or all quotation(s) without assigning any reason thereof.

### **Terms and Conditions:**

- 1.0 The rates should be quoted inclusive of all expenses like hire charge, POL (for approximately 03 hours per day), maintenance, boatman, incidental charges etc. No extra charges are payable except GST only on submission of valid receipts.
- 2.0 The above supply works shall be carried out as per requisitions contained in B.O.Q. (Annex-A) enclosed and as per directives of Director, IWAI, Kolkata or his authorized representative of Engineer-In-Charge.
- 3.0 The mechanized country boat shall be initially hired for 03 months for providing day to day assistance to CSD Shipra which will be further extended upto 31.03.2025 on phased bound manner subject to satisfactorily performance and certification by CSD Shipra dredging unit. On the other hand deployment period may be reduced similarly and deployment will be considered for actual working days only.

- 4.0 The mechanized country boat should be mobilized to Haldia dredging site within 03 (Three) days from the date of issuance of work order to the successful bidder. In case of any malfunction of the mechanized country boat, same to be replaced /repaired by the agency at their own cost within two days. No payment will be considered in case mechanized country boat is non-operational during any working day or part thereof.
- 5.0 The mechanized country boat should be well covered with thick plastic sheets and should be changed immediately if found damaged during the site activities.
- 6.0 On delay in supply of the boat, Liquidated Damage @ 1 % per week and maximum of 10% of the awarded value will be deducted from the supply bill
- 7.0 The firm will be required to submit original Tax-Invoice in duplicate at the time of submission of the claim. Payment will be released on monthly basis after successful completion of the work after necessary certification by Engineer-In-Charge or his authorised representative.
- 8.0 Firm shall submit the copy of PAN Card, GST registration certificate, copy of cancelled cheque & work experience of similar nature.
- 9.0 The firm shall submit the 02 nos. Judicial stamp paper of Rs. 100 for entering the agreement within 15 days from the issue of work order.
- 10.0 The security deposit @ 10% will be deducted from each bill. The SD @ 10% may be released after completion period of the contract
- 11.0 Incomplete quotations will be summarily rejected by Competent Authority.
