Sealed quotations are invited from the reputed Contractor/repairer/authorized dealer for Hiring of welding/cutting work and other allied work including Gas Cutting machine with manpower & welding machine with welder for the dredger units at MMT Haldia and Kolaghat Terminal for 6 months i.e from Oct 24 to Mar 25 as per annexure & terms and conditions laid down below. - (2) The hiring process may be done as per following terms and conditions mentioned below:
 - (i) The percentage may be quoted in both words and figures in annexure.
 - (ii) The price should be quoted inclusive of all costs, including equipment, manpower etc. The cost of material will be paid on an actuals + 10% basis, subject to the spares being fitted and supplied within the estimated cost. Any incremental spare costs must be approved by the Competent Authority. No additional charges will be entertained. GST will be extra as applicable.
 - (iii) The rate contract will take effect within 2 days from the date of receipt of the work order from R.O. Kolkata. The contract rate will be valid from October 2024 to March 2025
 - (iv) The firm must submit documentary evidence, including a current copy of the Registration Certificate, PAN, GST, and proof of experience with similar work.
 - (v) In case of a delay in providing the machine within 12 hours prior to the requirement, the contract may be cancelled.
 - (vi) The firm shall submit the 02 nos. Judicial stamp paper of Rs. 100 for entering the agreement within 15 days from the issue of work order
 - (vii) Payment will be made on a usage-based basis, calculated at the daily estimated rate for the equipment within 15 days after submission of the bills subject to satisfactorily completion of work and certification by the officer concern.
 - (viii) The repairer/firm participating in this repair work must have an office located in Kolkata, Howrah, or within a 100 km radius of Kolkata/Howrah.
