Inland Waterways Authority of India (IWAI) invites Sealed Quotations from experienced resourceful and reputed firm/contractors for Repair of Rudder Assembly (Port) of Bulk cargo vessel MV AAI at Low level Jetty, Gaighat, Patna. The detail of BOQ is enclosed as Annex-1.

The terms and conditions are as under: -

1. The repair work shall be completed within **10 (ten) days** from the date of receipt of work order as per directive of EIC.
2. The quoted price shall be excluding GST as per applicable and including transportation charges, labour charges as mentioned in scope of work etc. No other claim will be entertain.
3. Repairer shall be submit scanned copy of PAN card, GST certificate, firm registration certificate and MSME registration certificate.
4. The repairer shall have past experience related to similar nature of work/familiar with electrical/civil/mechanical work in river side/riverine work etc.
5. The repairer shall be submit Bank detail & cancelled cheque.
6. In case of delay in completion of the above repairing work and delivery, liquidated damages will be applicable @ 1.0% per week subject to a maximum 10% on the total value of the contract.
7. The payment shall be released on submission of bill/invoice alongwith work completion certificate duly certification by officers concerned within 15days.
8. The standard guarantee/warranty shall be applicable as per manufacturing norms/company rules and guarantee/warranty card/documents shall be submitted along with bill/invoice to this office.
9. The repairer/contractor shall submit the BOQ (Annex-1) after duly stamp and signature.
10. IWAI reserve the right to accept or cancel any quotation without assigning any reason or any prior notice.
