NOTICE INVITING QUOTATION

Sealed quotations are invited from the reputed boat supplier/contractor/vendor for "**Hiring of Mechanized Country Boat for CSD Brahmani's dredging work at Pandu - Neamati stretch**" as per **Annexure – BOQ** & as per terms and conditions laid down below. The NIQ can also be downloaded from IWAI's website (www.iwai.nic.in).

- (2) The work may be done as per following terms and conditions mentioned below:
- The boat is to be deployed at Pandu - Neamati stretch for CSD Brahmani's assistance while IWAI reserves the right to utilize the boat in any other urgent departmental work.
 - The rates are inclusive of all charges and delivery at site. The rates are exclusive of GST and no extra cost will be admissible except GST.
 - The above supply work is for 2 months and may extend only 1 (one) time for further 2 months if the service is found satisfactorily as well as willingness submitted by the firm.
 - The above supply shall be carried out as per specification mentioned in the **Annexure – BOQ**.
 - The firm has to submit documentary evidence of current copy of the Registration Certificate, PAN and GST.
 - Payment will be release after satisfactory completion of the supply and necessary certification by E.I.C. or his authorized representative within 15 days from the date of submission of GST format invoice/bill by PFMS/RTGS after deduction of the statutory dues if any. However, authority will not pay any amount in account of interest on any unavoidable delay in release of payment.
 - Supply of boat with Manjhee on hire charges basis shall be made available immediately after receipt of work order.
 - The boat shall be well equipped with all accessories and appliances as per existing rules and all safety provisions are to be made in the boat against any accident etc. by the supplier at his own initiative and cost.

- ix. Maintenance and repair of the boat shall have to be done by the supplier at his own initiative and cost to the satisfaction of the department.
 - x. The dredging unit requires mechanized country boat for Channel Checking, Transport of crew from dredger to Tug/Land/Accommodation Boat etc. and vice versa, Cutter Cleaning, shifting of any good likes barrel and rope etc. from shore to vessel and vice versa, Pipeline connection, dumping point inspection and providing bamboo marking.
 - xi. EIC or his authorized representative reserves the right to alter the duration of the work/reduce the quantity of the work as per actual requirement & as per site condition.
 - xii. Claim / claims for damages or loss of boat and life due to accident or otherwise either natural calamity or other reasons whatsoever shall not be entertained by the Department. However, Departmental assistance can be extended in case of salvaging purpose at the rate(s) fixed by the Department where it is susceptible if such facility exists.
 - xiii. Responsibility of safety and security of Manjhee/deployed manpower during works over land as well as in the water i.e. in the river will entirely rest with the supplier.
 - xiv. Necessary compensation in case of any accident will have to be paid by the supplier as per rule and it solely responsibility of the agency to take all necessary/applicable insurance policy etc. IWAI will not be held responsible for any such unforeseen events and no compensation shall be paid by IWAI.
 - xv. E-Payment will be made after submission of pre-receipted bills in triplicate by the supplier. No advance payment is admissible.
 - xvi. The supplier shall take care of all statutory compliance applicable to the work as per applicable acts/rules/regulations.
