NOTICE INVITING QUOTATION (NIQ)

Sub:- Erection and maintenance of bamboo Gangway/Jetty at floating Terminal, Manjhi Ghat, NW-40 (River Ghagra).

Inland Waterways Authority of India (IWAI), a statutory body under MoPS&W, Govt. of India invites sealed quotation from eligible contractor's firms/agencies for the work of Erection and maintenance of bamboo Gangway/Jetty at Floating Terminal, Manjhi Ghat, NW-40 (River Ghagra). Details of BOQ are enclosed at Annex -1

The terms and conditions are as follows:-

1. The firm should have experience to execute similar nature of work i.e. O & M of terminal or work related to erection/ installation of jetty/ gangway/mooring arrangement etc. The firm should submit self-certified copy of work completion certificate for the same.
2. The quoted price shall be including all cost, material, labour, taxes, levies, cess, transportation, GST as applicable etc. No other extra charges will be entertained.
3. The firm should submit self-certified copy of firm registration, PAN Card, GST registration and cancelled cheque along with the quotation.
4. 10% SD will be deducted from the bill and the same will be released after warranty period i.e. six month from date of completion of the work.
5. 90% Payment will be made through e-mode after completion of work and certification of the bill by IWAI officials/representative on monthly basis after deduction of the statutory dues if any.
6. The work for erection and maintenance of Gangway/ jetty shall be completed within 10 days from the receipt of work order, failing with liquidity damage (L.D.) @ 0.5% per week, maximum upto 10% of bill amount, will be imposed.
7. IWAI reserves the right to accept of cancel any quotation without assigning any reason or any prior notice.

The sealed quotation should reach to this office latest by 10.10.2023 upto 15:00 hrs. The same will be opened on 10.10.2023 at 15:30 hrs.
