**Sub:** Re-NIQ for hiring of Mechanized Boat with Boatman/operator from Jan'2025 to March'2025 (3.0 months) during dredging period for **CSD Kallada unit** for the FY 2024-25 at Ayodhya(UP) in NW-40(River Saryu)-reg.

Inland Waterways Authority of India (IWAI) invites Sealed Quotations from experienced resourceful and reputed firm/contractors for hiring Mechanized Boat with boatman/operator during dredging period of CSD Kallada unit under Ayodhya jurisdiction i.e. Nayaghat to Guptarghat from Jan'2025 to March'2025 in NW-40(River Saryu).The detail of BOQ is enclosed as Annex-1.

**The terms and conditions are as under: -**

1. The rate should be inclusive of all taxes (GST) as applicable and terms of price should be in Indian Rupees (INR). No other claims will be entertained. The GST amount shall be released on submission of its remittance.
2. The Service provider shall submit PAN Number, GST Registration, Cancel cheque (Copy).
3. Quotationer shall either own or shall have valid lease agreement for the complete contract period with owners of these boats etc.
4. Experience of having successfully completed similar works of supply of Mechanized boat including manpower on hire basis in rivers.
5. Payments shall be released on submission of bill within 15 days after deduction of statutory dues if any and duly certification by concern officials/officers and running charges will be paid on submission of HSD purchase bill & certified Log book.
6. The quotation must have validity of at least three months. The boat must be made be available as per requirement within 7 days on submission of indent for supply of Mechanized Boat with boatman/operator.
7. If the work has not completed within the stipulated time LD of ½ % per week is to be charged, subject to maximum 10% of the value.
8. Price bid shall be submitted in the format attached at Annexure-I which should be duly signed and stamped by the service provider and without any deviation/condition.
9. The sealed quotations shall be submitted up to 24.12.2024 before 15:00 hrs at IWAI, Patna along with copy of GST registration certificate, PAN card, copy of Mechanized boat ownership/lease certificate, Bank Account detail/Cancelled
