NOTICE INVITING QUOTATION

Sealed quotations are invited from the reputed firm / suppliers for supply of 01 (one) No. Mechanized country boat with Boat Man and 2 Nos. Pipeline crew on 24X7 basis (except weekly off for the crew) for logistic support & daily dredging activity of CSD Shipra, IWAI, in Tribeni- Farakka stretch of NW-1.

Terms & Conditions: -

1. The supplier should have credential for supply of mechanized country boat (minimum 7.5 BHP) in last 03 years.
2. The mechanized country boat is presently to be deployed with CSD ID IV unit. In case requirement is felt necessary, it may also be deployed at other stretch & other stretch of NW-1 under Kolkata directorate.
3. The rates are to be quoted both in words and in figures. The rates shall be inclusive of all charges and delivery at site.
4. Supply of mechanized country boat with Boat Man and Pipeline crew on hire charges basis should be made available immediately on issue of the order at the proposed site. No mobilization charges should be paid.
5. The boat shall be well equipped with all accessories and appliances as per existing rules and all safety provisions are to be made in the boat against any accident etc. by the supplier at his own initiative and cost. The Safety gears (Buoys/Life jacket) are mandatory.
6. Maintenance and repair of the boat shall have to be done by the supplier at his own initiative and cost to the satisfaction of the department. Alternative mechanized country boat should be arranged immediately as replacement in case of defect in the supplied boat.
7. The actual site of operation of boat services will be intimated by the Engineer-in-Charge or his authorized representative.

9. Responsibility of safety and security of crew during works over land as well as in the water i.e. in the river will entirely rest with the supplier.
10. Necessary compensation in case of any accident will have to be paid by the supplier as per rule and it solely responsibility of the agency IWAI will not be held responsible for any such unforeseen events and no compensation shall be paid by IWAI.
11. E-Payment will be made after submission of pre-receipted bills in triplicate by the supplier. No advance payment is admissible.
12. Payment will be made by PFMS/RTGS within 15 days from the date of completion of the work and certification of the bill by the officer concerned after deduction of the statutory dues.
13. The firm should also require to submit self-certified copy of PAN Card, Registration certificate, GST, and credential certificate etc.
14. The supplier shall submit a copy of Labour License (i.e. registration under Contract Labour (Regulation & Abolition) Act 1970). Further, the Bidder shall also submit an undertaking to the extent that the employees are paid not less than the remuneration notified as per Ministry of Labour & Employment order F. No. 1/8(4)/2023-LS-II dated 26.09.2023.
