- 1. The quoted price shall be including all cost, taxes, levies, cess, GST as applicable etc. No other extra charges will be entertained. The above work should be executed as per BOQ and as per direction of Engineer-incharge.
- 2. Payment will be made through e-payment after completion of work and duly certification of the bill by concerned officer after deduction of the statutory dues if any.
- 3. The firm should also submit self certified copy of PAN Card, GST registration, registration certificate of similar work, civil work, related to similar/relevant work experience & bank account details along with a cancelled cheque.
- 4. The Payment will be made after deduction of applicable taxes etc. if any. The payment against the bill only after satisfactory completion of work and certification of bill by the authorized person.
