- 1. The price may be quoted labour, charges, taxes, transportation etc. as per annexure. Cost of spares on actual plus 10% basis. GST as applicable shall be reimbursed. No other extra charges will be entertained.
- 2. The work to be completed within 15 (Fifteen) days from the date of placement of work order.
- 3. In case of delay in completion of repair, liquidated damage @0.5% per week subject to a maximum of 10% will be charged.
- 4. The firm should also require submitting self-certified copy of PAN Card, GST registration, registration certificate, copy of work experience certificate etc. related to Air-conditioning repair, etc.
- 5. 90% Payment will be made by cheque or RTGS within 15 (Fifteen) days from the date or received of the bills and duly certification by the officer concerned after deducting the statutory dues if any.
