**NOTICE INVITING QUOTATION (NIQ)**

Quotations in sealed envelope are hereby invited by undersigned from reputed contractors/agencies for supply of necessary unskilled workmen for cleaning of water hyacinth/underwater weeds from D/s Jangipur Barrage channel (near chainage 505 km on National Waterway No:1 on left bank) as per terms & conditions given below. The details of the work and B.O.Q are enclosed as Annexure – I with N.I.Q. which is to be filled in and submitted along with a forwarding letter addressed to **Director, I.W.A.I., P-78, Garden Reach Road, Kolkata-700043**

Sealed quotations will be received upto **3:00PM on 07/07/2023** and will be **opened on same day at 4:00PM**. The contractors/agencies or their authorised representatives who have submitted the quotations may also be present during opening of same by the committee members of IWAI.

Rates should be quoted for service charges only in percentage (%age). The rates shall be quoted legibly both in figure and words and shall be valid up to 90 (Ninety) days from the date of opening. The work for which quotation has been submitted should be clearly written on the top cover of sealed envelope.

I.W.A.I. reserves the right to accept or reject any or all quotation(s) without assigning any reason thereof.

**Terms and Conditions:**

- 1.0 The rates should be quoted inclusive of all expenses no extra charges will be payable, statutory dues (if any), G.S.T. and Safety items.
- 2.0 The above supply work should be as per the BOQ & directives of Engineer in Charge or his authorised representative.
- 3.0 Maximum estimated deployment is 360 Man-Days. However, the actual deployment may vary as per site requirement.
- 4.0 Necessary wages and dues for a wage month are to be remitted as per latest minimum wages schedule notified by Central Labour Commissioner to the engaged workmen as per actual requirement of site within 1<sup>st</sup> week of next month in their respective bank accounts. Agency will be required to submit the receipt of such transaction while submitting the claim.
- 5.0 The engaged labour should be covered under statutory schemes as per the government norms as per their eligibility.
- 6.0 Full payment will be released only after satisfactory completion of the work and necessary certification by E.I.C. or his Authorised representative within 30 (Thirty) days after satisfactory completion of the work. However, Authority will not be responsible for any unavoidable delay.

- 7.0 The firm will be required to submit Tax-Invoice in duplicate at the time of submission of the claim.
- 8.0 The quotation should accompany GST registration, valid Trade License and details of registration with E.P.F.O. and E.S.I.
- 9.0 Incomplete quotations will be summarily rejected.
- 10.0 On delay in work L.D. @ 0.5% per week will be deducted from the final payment and maximum of 10% of the work value.
