NOTICE INVITING QUOTATION (NIQ)

1. Introduction

Inland Waterways Authority of India (IWAI), invites sealed Quotation from reputed logistics services firms in single cover for "Loading, Transportation and Unloading of PB Falcon-II vessel from Delhi to Prayagraj".

2. Critical Data Sheet

3. Scope of the Work

- (a) Loading of vessel from storage cum pump house of Irrigation Department, Delhi at Sonia Vihar near Wazirabad Barrage.
- (b) Transportation of vessel from Sonia Vihar, Delhi to IWAI office at Nawab Yusuf Rd, Sangam Vihar Colony, Civil Lines, Prayagraj, Uttar Pradesh.
- (c) Unloading of vessel on river from Ghat within vicinity of 5 Km of IWAI, Prayagraj office.
- (d) Manpower, equipment, vehicles and any other material/ facilities required for loading, unloading and transportation of vessel shall be the responsibility of the bidder.
- (e) Documents and relevant permissions required for the work shall be the responsibility of the bidder.
- (f) Any damage to the vessel due to the bidder during loading, unloading or transportation shall be the responsibility of the bidder and will be recovered from any money due or to become due to the Contractor.
- (g) List of fixtures, tools, materials etc. in the vessel will be jointly prepared with IWAI and Contractor's representative before loading of vessel at Sonia Vihar, Delhi. Same shall be verified and certified by IWAI's representative at Prayagraj office and shall be submitted with the bill.
- (h) The bidder is required to take insurance to cover all risk from an approved insurance company and bear all costs towards the same for the full period of execution of work.

- 4. **Timeline:** The completion time for the work shall be 20 (twenty) days from the date of award of work.
- 5. The quotation shall include the following documents:
- (a) Copy of PAN Card of the firm.
- (b) Copy of the GST registration certificate.
- (c) Letter of authority for signing and negotiation of quotation (as the case may be).
- (d) Original NIQ duly signed and stamped by authorized signatory on each page.
- (e) Schedule of price duly filled in the specified form Fin-1.
- 6. The price quoted will squarely and totally include all the charges to be paid to the Contractor for completion of work and shall include all duties, taxes, royalties and other levies payable by the Bidder for executing the work, except for GST which will be paid as per existing rules and regulations at the time of payment. The rates and prices quoted by the Bidder shall be fixed for the duration of the work and shall not be subject to adjustment.
- 7. The prices shall be quoted by the Bidder entirely in Indian Rupees. All payments shall be made in Indian Rupees (INR) only and shall be subject to applicable Indian Laws for the purpose of taxation, if any.
- 8. Bid shall be considered as non-responsive if it contains any condition or qualification or suggestion.
- 9. Payment: The total price payable for the work shall be stipulated in the LoA and 100% of the payment will be made after successful delivery and unloading of vessel in good condition without any transit damage. The bidder will furnish the bill along with all relevant supporting documents at IWAI Prayagraj office for certification by the Officer-in-charge or their representatives. The Officer-in-charge or their representatives would certify the bills within 15 days of receipt of bill and shall forward the same to IWAI, Noida for payment.
- 10. Security Deposit: The successful bidder is required to deposit an amount equal to 10% of the awarded cost for the work, as security deposit within 5 days of award of work. The security deposit shall be in the form of RTGS/NEFT/ Demand draft and shall be valid for atleast 45 days beyond the completion of work in case of DD. The security deposit shall be returned to the bidder on successful completion of work and payment of final bill, provided that there is no demand outstanding against the bidder.
- 11. **Completion period & Liquidated Damage:** Period of completion of work is 20 (twenty days) from the date of award of work. If the bidder fails to complete the work within the stipulated period without the justifiable reason for the delay, then LD for such default and not as penalty shall be levied at the rate of 0.5% of total value of work for per day of delay, subject to a maximum of 10% of awarded cost. IWAI may, without prejudice to any other method of recovery, withheld / deduct the amount of such damages from any money due or to become due to the Contractor. The amount withheld or deduction against such damages shall not relieve the bidder from his obligation to complete the Work.
- 12. All the quotations wherein the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.
- 13. **Validity:** The quotation shall be valid for a period of 60 days from the date of opening of quotation.
