**Name of work:** - Fabrication and supply of 25 nos. Security cages for Navigational Lights in NW-3.

## **ANNEXURE-I**

### **Technical specifications and Terms and conditions**

1. The fabrication and supply of 25 nos. security cages for navigational lights shall strictly adhere to the enclosed design.
2. MS Plate, angles , MS bar used for fabrication shall be of good quality.
3. The items are to be delivered within 45 days after issuance of work order.
4. Security cage should be of size 380 mm x 360 mm x 300 mm size as per the design enclosed with a suitable locking system. Two coats of marine quality epoxy paint (Black) has to applied over the epoxy primer.
5. The epoxy paint shall be of good quality which should be able to withstand weathering. The paint brand and quality shall be approved by IWAI before applying.
6. The entire locking system has to be made of stainless steel and fitted with standard quality fixtures and fastenings and good quality grease. Bird spike has be provided as per design.
7. The bidders are to familiarize with the existing locking system which is already in use with the lighted buoys.
8. Payment will be made for 100% completion of ordered quantity. The work has to be executed under the supervision of EIC or his representative.
9. The work will be inspected by the EIC or his nominee from time to time and if any deviation or shortfall noticed in the specifications, etc. shall be rectified immediately by the contractor at his own cost to the satisfaction of EIC before taken over by the authority.
10. No initial or advance payment will be paid on behalf of this work. The entire payment will be paid on only after satisfactory completion of work.
11. No transportation charges will be paid. The items have to be supplied at Regional office, IWAI, Kochi.
12. The Pan Card and GST certificate has to be furnished along with bank account details by the contractor.
13. The payment will be made through RTGS mode of payment within 15 days from date of submission of bill in duplicate.
14. The rates quoted shall be inclusive all charges in complete and no extra charges will be payable on any reason.
15. The bidders shall submit an amount of Rs. 16,300/- as Security deposit in favour of IWAI, Kochi along with the bid. The payment shall be made online via **RTGS only** to the following bank account:


