Quotations in sealed envelope are hereby invited by Director, IWAI, Kolkata from reputed contractors / hydrographic survey instruments repairing agencies for repairing of one number dual frequency Bathy Echosounder and Transducer as per terms & conditions given below. The instrument pertains to IWAI Sub Office Swaroopganj, Dist- Nadia, West Bengal and the address of sub office Swaroopganj office (collection of defective echosunder and transducer 210 khz) is Village: Fakirtala, P.O: Maheshganj, Nadia, Pin-741315. The details of the work and B.O.Q are enclosed as Annexure – A with this N.I.Q. which is to be filled in and submitted along with a forwarding letter addressed to Director, IWAI, Kolkata..

Sealed quotations will be received up to 1500 hrs. on 30.01.2023 at the office of the Director, I.W.A.I., P-78, Garden Reach Road, Kolkata – 700043 and will be opened on same day at 1600 hrs. The bidder or their authorized representatives may be present during the opening of NIQ.

Rates should be quoted inclusive of all charges excluding GST as per BOQ attached . The applicable GST may be mentioned in the BOQ. The rates shall be quoted both in figure and words without over writing and should be legible. This NIQ will be valid up to 90 (Ninety) days from the date of opening. The name of the work should be clearly written on the sealed envelope along with reference number with date.

I.W.A.I. reserves the right to accept or reject any or all quotation(s) without assigning any reason thereof.

### Terms and Conditions:

- 1.0 The rates should be quoted inclusive of all taxes, labour, transportation etc. no extra cost will be admissible.
- 2.0 The above work shall be carried out at the address mentioned in Para-1 as per specification mentioned in the B.O.Q. (Annexure I) and direction of E.I.C. or his representative.
- 3.0 The above work shall be completed within 15 (fifteen) days from the date of issue of the work order which includes collection of defective instruments from IWAI Swaroopganj Sub Office and repairing period.
- 4.0 The warranty shall be for 180 days of repair / replace items from the date of testing and satisfactorily acceptance of the repaired instrument. In case , any malfunctioning of repaired instrument is found for the replace /repaired items during warranty the agency shall undertake the repairing of same free of cost and no service charges shall be entertained.
- 5.0 The payment will be released only after satisfactory completion of the work and necessary certification by E.I.C. or his Authorised representative. The 10% of the awarded work shall be deducted from the bill as security deposit which released after 180 days from completion of work subject to satisfactorily completion of the work and No Dues Certificate issued by EIC.
- 6.0 Participating bidders should have valid GST and trade registration and the self certified copies should be submitted along with the quotations.
- 7.0 Incomplete quotations will be summarily rejected.
- 8.0 On delay in work L.D. @ 0.5% per week will be deducted from the final payment and maximum of 10% of the work value.
