NOTICE INVITING QUOTATION

Sealed quotations are invited from the reputed firm dealing in fuel monitoring & GPS tracking system for installation of the same in IWAI vessels as per Annexure – BOQ & as per terms and conditions laid down below. The NIQ can also be downloaded from IWAI's website (www.iwai.nic.in).

- (2) The work may be done as per following terms and conditions mentioned below:
 - i. Installation of fuel monitoring system along with level RPM & hour meter sensors providing software application where monitoring of installed system can be done along with GPS tracking.
 - ii. The rates are inclusive of all charges and delivery at site. The rates are exclusive of GST and no extra cost will be admissible except GST.
 - iii. The charges including accessories and configuration and calibration of the sensors, fuel tank, running hour with fuel consumption on RPM load chart along with various software report for clear interpretation.
 - iv. The GPS tracking system must have a remote Technical support and initial software report real time GPS monitoring of vessels.
 - v. Payment will be release after satisfactory completion of the installation and necessary certification by E.I.C. or his authorized representative within 15 days from the date of submission of GST format invoice/bill by PFMS/RTGS after deduction of the statutory dues if any. However, authority will not pay any amount in account of interest on any unavoidable delay in release of payment.
- vi. The Tracking & Fuel monitoring system shall be well equipped with all accessories and appliances as per existing rules and all safety provisions are to be made in the boat against any accident etc. by the supplier at his own initiative and cost.
- vii. Maintenance and installation of Fuel and GPS tracking system in vessel shall have to be done by the firm at their own initiative and cost to the satisfaction of the department.
- viii. Installed equipment / sensor must depict proper fuel consumption with corresponding RPM & Running hours report of each unit DG and Engines (total 4) of each unit.
 - ix. The firm shall take care of all statuary compliance applicable to the installation work as per applicable acts/rules/regulations.
- (3) The sealed quotation should reach this office latest by **02.09.2024** at **15:00** hrs and will open on same day at **15.30** hrs. No quotation will be accepted after the last date and time for submission of quotations.
