- 2. The quotation shall include
 - i. The amount may be quoted in both words and figures as per annexure –A.
 - ii. The amount may be quoted excluding GST.
 - iii. The firm has to submit documentary evidence of current copy of Registration certificate of the firm, PAN, GSTIN certificate
 - iv. Copy documentary evidence of providing boats to Govt. deptt/ PSU's.
- 3. The terms and conditions for hiring of boat will be as per Annexure –B.
- 4. The sealed quotations in original should reach this office latest by 20-11-2024 at 17:00 hrs. No quotations will be accepted after the last date and time of submission of quotations.

The interested agencies should submit their quotations in the prescribed format for Financial Bid (Annexure 'A) strictly following the Terms and conditions (Annexure B') after signing each and every paper along with the seal/stamp of the Agency in sealed envelope super scribing it as "Quotation for Empanelment of Agencies for hiring of Mechanized Boat" and shall be submitted in the office of the Director, Inland Waterways Authority of India, Pandu Port Complex, Pandu, Guwahati - 781 012 before closing date and time as mentioned above. Quotations received after the closing date & time shall not be considered.

The Quotations will be opened on 20-11-2024 at 11:00 AM in the presence of the Tender Committee in the office of the Director. Inland Waterways Authority of India, Pandu Port Complex, Pandu, Guwahati - 781012.

TERMS & CONDITIONS

- The Bidder should be a registered firm/Company.
- The Bidder should have a valid PAN and should attach a copy of the same.
- The Bidder should submit an undertaking that he/she or his/her firm has not been blacklisted by any Govt. Department / Organization as on date of submission of the Bid.
- 4. The Agency shall provide the name and contact details of the Pilot & Dandi during their deployment. The Agency shall also ensure that the Pilot & Dandi do not have any police record/ criminal case against them.
- The boats should be fit for hiring out to other agencies.
- All boats should be fit and well maintained both from inside and outside. IWAI will not be responsible for failure in running and road condition.
- The desired boat(s) must be provided as and when requested by the Authority.
- 8. The boat(s) should be made available on all days including Saturday, Sundays and holidays as per actual requirement.
- The boat should be equipped with sufficient quantity of fuel during the duty period.
- The boats should be properly and comprehensively insured and should carry all the necessary documents from the Regional Authorities or any other concerned authority. The loss or damages or legal expenses, if any, on this account shall be bourne by the Bidder.
- No payment shall be made in case the boat does not report for duty on any day(s) alter being requisitioned by this Office. In addition, a penalty of Rs. 500/- per day shall be levied if any boat/agency fails to meet the above conditions on any day.
- The agency should have at least one year of experience of providing boats to Govt. Departments/PSUs.
- 13. The boat(s) shall primarily be used for NW-16 and IBP Route 3,4 & 7,8 (Bhanga Karimganj stretch). However, the Authority may ask the agency to provide the boat(s) in other National waterways in NER also depending upon the requirement.
- 14. All the Pilot & Dandi should have well presentable appearance and should attend duty in uniform and should be well aware about the navigational channels in NW-16 and adjoining IBP Route.
- 15. The Pilot & Dandi deployed should carry a mobile set. Mobile charges will not be bourne by this Office.
- 16. Berthing and toll charges shall be reimbursed on actual basis. Any other charges like fooding and lodging of the crew to maintenance, insurance, pollution clearances, etc. would solely and wholly be the responsibility of the Contractor / Agency.
- 17. There is no guarantee towards hiring of any specific boat or for any specific period. The Bidder shall provide as many boats as required by this Office and for any specific

period as the case may

- 18. The contract will initially be for one-year period from the date of issue of a work order/empaneled. However, IWAI reserves the right to extend the contract for another three years period (one year at a time) with mutual consent with 5% escalation each year after completion of one year period on the awarded rates and as per terms and conditions of previous agreement after getting willingness from the concern contractor and subject to satisfactorily performance of the works.
- All expenses relating to salary and allowances of the crew, overtime payment, maintenance of boat, charges of fuel oil or any other expenditure related to the boat and the crew will be borne by the service provider.
- In case of any breakdown of boat, mileage from repair facility to the point of breakdown would not be paid.
- 21. All the taxes will be deemed included in the quoted rates except GST, which shall be shown by the selected agency in the bills/invoices separately and will paid in accordance with the prevailing rates.
- 22. The validity of the Financial bid shall be 90 days from date of opening of Quotation.
- Duty hours for a boat will be 12 hours in a day and beyond that overtime charges shall be paid.
- 24. The night halt charges during out station duty shall be paid per night stay.
- Bill has to be submit on end of the month of journey performed.
- No other charges shall be paid except charges mentioned in Duty Rates and as terms and conditions.
- 27. The contract may be terminated by either side by giving at least one month prior notice.

Payment Terms

- Amount payable for hiring of any boat shall be on daily hire charge basis and running charges shall be paid on per hour basis from the reporting point to the relieving point.
- Bills shall have to be submitted on monthly basis along with original log sheets duly certified by the officer using the boat and requisition slip by concerned officer.
- Payment shall be released within 30 days of submission of the bill subject to verification and certification of user.
- Due payment will be released to the agency through PFMS / RTGS only after deduction of statutory taxes and charges as applicable.
