NOTICE INVITING QUOTATION

1. Sealed quotations are invited from the reputed Contractor for **Repair/replacement of damaged crew shelter on CPB-V at Karimganj (Assam)** as per BOQ (Annex-I), Typical Drawing (Annexure-II) & as per terms and conditions laid down below. The NIQ can also be downloaded from IWAI's website (www.iwai.nic.in).
2. The repair work may be done as per following terms and conditions mentioned below:
 - i. The price may be quoted in both words and figures.
 - ii. The price may be quoted including all the cost such as Labour, Transportation charges, all taxes excluding Good & Service Tax (GST) as applicable which will be paid on production of proof of payment. **No other charges shall be entertained.**
 - iii. The repair and replacement work must be completed within 20 days from the date of issue of work order by IWAI.
 - iv. The firm has to submit documentary evidence of current copy of the
 - a. Registration Certificate of the firm with State PWD/MES/Railways etc.
 - b. Permanent Account Number, GST registration certificate
 - c. Valid Trade license
 - d. Labour license
 - e. Self-certificate stating that the bidder has not been banned or de-listed by any Govt. or Quasi Govt. agency or Public Sector Undertaking for the past 3 years.
 - f. Work completion certificate of having successfully completed similar works as mentioned below during the last 7 years ending last day of month previous to the one in which tender is invited
 1. Three works costing not less than 40% of the estimated cost; or
 2. Two works costing not less than 50% of the estimated cost; or
 3. One work completed not less than 80% of the estimated cost
 - v. The quantity actually executed shall be certified by EIC as per terms and conditions of the order and payment shall be made by RTGS/ NEFT within 10 days from the date of receipt of bill and challan after satisfactorily work done. The copy of bank details shall be submitted along with quotation.
 - vi. The work completed shall be guaranteed against any defect or workmanship for a period of 12 calendar months from the date of completion. During this guarantee period, in case of any defective material or workmanship the

guarantee period, in case of any defective material or workmanship the contractor will undertake to repair any part or portion thereof, at the site without any cost to IWAI. The contractor will also undertake to attend complaint at the site within 24 hours of getting the intimation either by telephone, letter or fax. The guarantee shall be given by the Contractor on non-judicial stamp paper before the submission of final bill.

- vii. In Case of delay in completion of work liquidity damage @0.5% per week subject to a maximum of 5% will be charged.
 - viii. The firm shall be having experience for civil construction, repair and renovation of civil structures.
 - ix. IWAI reserves the right to accept or cancel any / all quotations without assigning any reason or any prior notice.
 - x. Security Deposit of 5% will be deducted from the bill. The same shall be released after completion of the guarantee period (12 months)
3. The sealed quotation should reach this office latest by **22.02.2023** at **12:00 hrs** which will be opened on **22.02.2023** at **15.30 hrs**. No quotation will be accepted after the last date and time for submission of quotations.

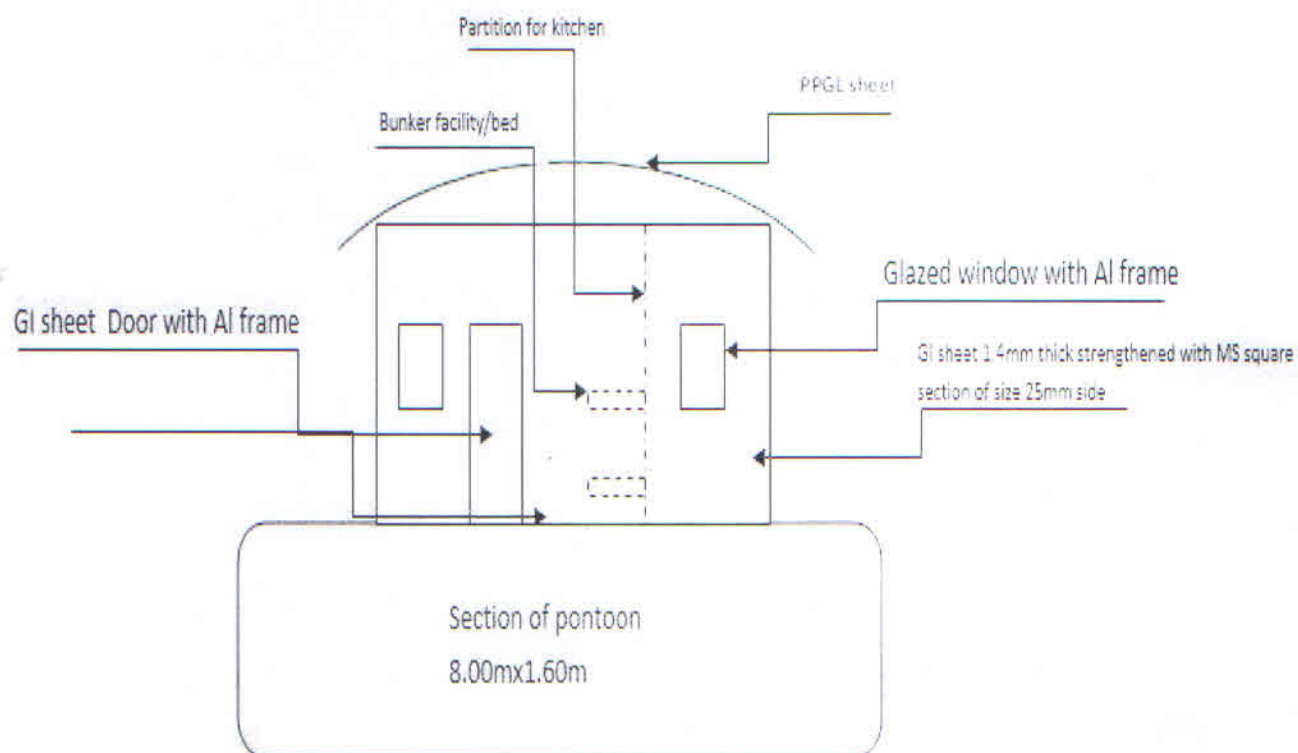
