Inland Waterways Authority of India invites sealed quotations for Supply of 10 nos. of wooden tide gauges from reputed supplier/ contractor having experience in work above mentioned items. The tide gauges will be erected in NW-3, for observing water level variations.


Terms and conditions:

1. The wood used should be Anjili wood or equivalent good quality wood suitable for making of tide gauge that lasts long in water body.
2. Two coats of good quality white enamel paint have to be applied over one coat of primer.
3. The dimensioning shall be made with black paint and the graduation are grove cutting using fine tool and finishing with painting.
4. The size of the gauge shall be 275 cm x7.5 cm x 5cm and graduated as per design enclosed in annexure-I.
5. The quotation should reach on or before 25.7.2024 by 1500 Hrs.

6. No initial or part payment will be paid on behalf of this work. The entire payment will be paid on only after satisfactory completion of work.
7. The approval of Engineer-in-Charge or his representative on quality of wood and paint shall be obtained by the contractor before starting of the work.
8. The gauges shall be supplied at IWAI RO, Kochi, Maradu-682304 within 30 days from the date of issuing of Work order.
9. The Director has right to cancel the work without giving notice thereof.
10. The payment will be made within 15 days from date of submission of bill through PFMS.
11. The rates quoted shall be inclusive all charges in complete and no extra charges will be payable on any reason.
12. A copy of PAN card & GST registration is required to be enclosed along with the offer submitted by bidder.

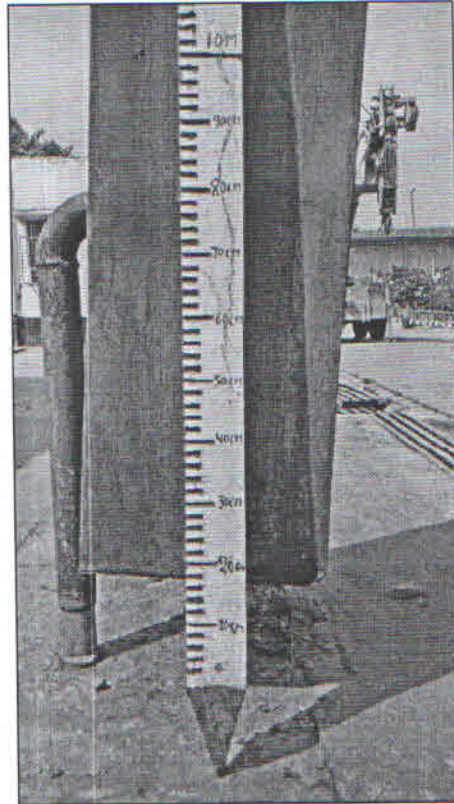
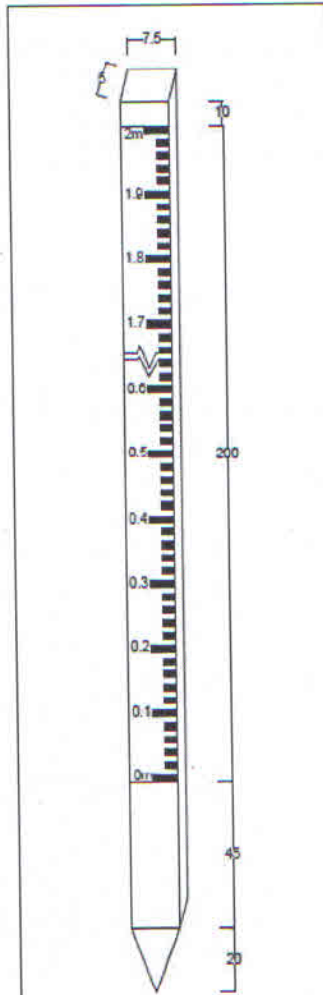
