NOTICE INVITING QUOTATION (NIQ)

Inland Waterways Authority of India (IWAI) invites Sealed Quotations from experienced resourceful and reputeted firm/contractors for transportation of HDPE Dredging pipeline of Dredger CSD Kallada by Road from Gaighat, IWT, Patna to Ayodhya at Nayaghat (UP) in NW-40(Saryu River). The terms and conditions are as under: -

- 1. The firm shall be submitted the copy of PAN Card, GST Registration, Cancel cheque, firm registration certificate, transport licence certificate and similar work experience certificate.
- 2. Payments shall be released on submission of final bill along with receipt of challan within 15 days after deduction of statutory dues if any and duly certification by concern officials/officers.
- 3. The material shall be loaded at Gaighat, Patna and all necessary arrangement for loading & unloading will be done by the transporter at Gaighat, Patna and Ayodhya at Nayaghat(UP) in NW-40(Saryu River) respectively at their own cost on arrival at Ayodhya at Nayaghat(UP) in NW-40(Saryu River).
- 4. Interested transporter may inspect the material on any working day on 17.10.2024 to 23.10.2024 from 1100 hrs to 1700 hrs at low level jetty at Gaighat, Patna.
- 5. In case of any damage/loss, transporter shall be responsible to make goods and remedy, at his own cost, within such period as may be stipulated by the Director, IWAI, Patna.
- 6. The quotation will be valid for a period of not less than 90 days after the date of opening of quotations. The quotations should be submitted in the enclosed bill of quantity as Annex-I duly signed & with stamp.
