NOTICE INVITING QUTATIONS

Inland Waterways Authority of India (IWAI), a statutory body under Ministry of Ports, Shipping and Waterways, Government of India invites sealed quotation from a reputed/bona-fide/resourceful agencies having experience in the particular field for installation work of 06 nos. CCTV Cameras at IWAI Haldia Multi-Modal IWT Terminal.

Annexure-II and should be submitted along with each signed page of NIQ and all required documents as mentioned below in a sealed envelope superscribing "Quotation for installation & commissioning of 06 nos. CCTV Cameras at IWAI Haldia Multi-Modal IWT Terminal" to The Director, IWAI Kolkata, P-78, Garden Reach Road, Kolkata – 700048, W.B. on or before 23rd October 2024, 15:30 hrs. The quotation received after the stipulated date and time shall not be entertained. Terms & Conditions and detailed specification are given below.

A. Terms & Conditions:

- 1. The bidder should have valid PAN Card. The copy of PAN Card to be submitted.
- 2. The bidder should have valid GST Registration. The copy of GST Registration to be submitted.
- 3. The bidder should have valid Trade License. The copy of Trade License to be submitted.
- 4. Income Tax return should be submitted of last 3 years (2021-22, 2022-23, 2023-24).
- 5. The bidder has to quote the price for the items as per specifications mentioned in **Annexure-II**.
- 6. The price quoted shall include taxes excluding GST, other levy payable, all freight, packing & forwarding, transportation, loading & unloading, custom duty, excise duty & other duties, other charges (if any) to supply the item(s)/goods/ service(s) mentioned in Annexure-II at MMT Haldia Site.
- 7. The Authority reserves the right to reject any or all quotations without assigning any reason whatsoever. The authority also has the right to extend the period of submission of bid/quotation, by issuance of notice through office notice board/website, if the circumstances so warrants.

- 8. The Authority reserves the right at the time of purchase/contract award to increase or decrease quantity of item(s).
- 9. The rates quoted also shall include training, installation, commissioning, erection and demonstration of item(s)/goods/ services(s) at MMT Haldia site.
- 10. Installation, testing & commissioning of all the components/ equipment / accessories, etc. as per technical specifications, and handing over to the IWAI, Kolkata. All the cabling and consumables items will be billed as per actual consumption.
- 11. The necessary shut down, temporary connection of electric supply has to be taken by the successful bidder before initiating the work.
- 12. All work has to be carried out by the firm in accordance to safety standards.
- 13. The successful bidder will be fully responsible for any accident or mishaps involving workers engaged by him and the vendor would pay claims made by these victims. The successful bidder shall execute the above side work without hampering the IWAI's Terminal properties otherwise they shall be liable to pay for any damage, harm or destructions caused by any act of them to the property of IWAI and delay, losses, damages, expenses or penalties that may be incurred to IWAI due to the successful bidder will be deducted from their bill. Any damage to the Terminal properties shall be repaired and restored back to original condition by the bidder with own cost.
- 14. During the period of work, if any mishap occurs due to electrocution or faulty fitting or any causes, it will be the responsibility of the contractor to compensate the loss on account of injury to any person. IWAI will not to take any responsibility in this regard.
- 15. The successful bidder shall not disturb or damage the existing network of CCTV Surveillance System. If in case any damage to the network is done, the same shall be corrected with no extra cost.
- 16. The bidders are advised to visit and examine the installation site and its surroundings and obtain for itself on its own responsibility all information that may be necessary for preparing the Bid. The costs of visiting the site shall be borne by the Bidder. Any enquiry after submission of the quotations will not be entertained.
- 17. The agency should not be blacklisted/debarred by any Ministry Govt. of India or by Government of any other State in India or any of the Government PSUs or Globally. The vendors must submit the declaration on the company letter head for the above at the time of bidding.
- 18. No bidders shall withdraw his rates after the quotation is opened. If a bidder does so, that bidder shall be considered ineligible for work/contract in IWAI in future. Violation of any of the conditions of the NIQ should be treated as breach of contract and 10% balanced amount may be forfeited as per discretion of the Competent Authority.
- 19. The quotations will be opened on 24th October 2024, at 11:30 AM at IWIA Kolkata office. no separate information shall be given to individual bidders.

B. Final selection and award of the work:

 The quotationer who quotes lowest rate, shall be selected for award of the work and IWAI will issue work order to the lowest quoted successful quotationer.

C. Delivery Period & Penalty:

- The ordered items(s)/goods are to be delivered and installed within a maximum time limit of 02 (two) weeks from the issue date of Work Order.
- 2. Time allowed for completion of installation work shall be strictly followed otherwise, the supplier shall be liable to be penalized at the rate of @1.5% of the order value for per day of delay.

D. Terms of Payment:

- 1. 90% payment of the bill amount shall be made by RTGS/PFMS within 15 days from the date of receipt of bill after satisfactorily work done and certification of concerned officer. The copy of RTGS details shall be submitted along with quotation. 10% Balance amount will be deducted from the bill as a Security Deposit and the balance amount will be released after expiry of defect liability period i.e. 12 months from the actual dated of completion of the work.
- 2. TDS and other deduction (if any) as per Government Order will be deducted from the bills.
- 3. No interest will be paid due to late payment of the bill, as submitted by the contractor. GST will be paid, as applicable.

4. Advance payment will not be made under any circumstances.
