NOTICE INVITING QUOTATION

Sealed quotations are invited from the reputed supplier/Authorized dealer/manufacturer for supply, fabrication and installation of 5 KWH Solar power off grid system in SL Dibang as per Annexure – BOQ & as per terms and conditions laid down below. The NIQ can also be downloaded from IWAI's website (www.iwai.nic.in).

- (2) The work may be done as per following terms and conditions mentioned below:
- The supply and installation should be completed with 15 days for the date of receipt of work order.
 - The Solar system shall be installed at specified location of the vessel, as per direction of EIC.
 - Payment will be released after satisfactory completion of the installation and necessary certification by E.I.C. or his authorized representative within 15 days from the date of submission of GST format invoice/bill by PFMS/RTGS after deduction of the statutory dues if any. However, authority will not pay any amount in account of interest on any unavoidable delay in release of payment.
 - The firm should submit self-certified copy of PAN card, GST registration number, last year ITR along with the quotation, Bank details & Cancelled cheque where payment to be made, similar work done certificate.
 - 10% of the bill amount will be withheld against warranty of the work.
 - Material warranty from OEM must be submitted such as Solar Panel, Inverter, Warranty for wires & cables.
 - Non-conformity to specifications due to faulty manufacturing and / or inspection processes. If the solar panel fails to conform this warranty, the manufacturer will repair or replace the solar panel, at the owners sole options.
 - The installation warranty should be of minimum 6 months.
 - The firm shall take care of all statutory compliance applicable to the installation work as per applicable acts/rules/regulations.
- (3) The sealed quotation should reach this office latest by **05.10.2024** at **15:00 hrs** and will open on same day at **15.30 hrs**. No quotation will be accepted after the last date and time for submission of quotations.
