

NOTICE INVITING QUOTATION

Inland waterways authority of India (IWAI) invites quotations from experienced and reputed firm/company for erection procurement of 4 Core Aluminium XLPE Armoured Cable (150 Sq. MM & 95 Sq. MM) for providing Shore Panel Facility to Hydrogen Fuel Cell Vessel as per the quantity and specifications in the BOQ enclosed as at **Annexure – 1**.

The terms and conditions are as under:-

- 1.) The price may be quoted including all the costs such as cost of material, transportation to the site, loading / unloading charges etc. of required quantity electrical cables as per annexure-I. No other extra charges will be entertained except GST as applicable.
- 2.) Proper / expert care shall be given while handling the items and transportation should be undertaken as per Government Guidelines / Traffic rules.
- 3.) The items shall be supplied at MMT, Varanasi, within 7 (Seven) days from the date of issue of the work order.
- 4.) The firm should also require to submit self-certified copy of PAN Card, GST registration certificate and credential certificate of similar nature of work.
- 5.) The payment will be made by RTGS within fifteen days from date of receipt of the bill and duly certification of the bill by the officer concerned after deducting the statutory dues if any.
- 6.) The work shall be under guaranteed period of six months from the date of completion of work.
- 7.) Warrantee / Guarantee Cards along with a copy of the original invoice shall be furnished along with the final bill.
- 8.) In case of delay in supply of items at site, liquidated damage 1% per week subject to a maximum of 10% will be charged.
