NOTICE INVITING QUOTATION (NIQ)

Sub: Notice Inviting Quotation for hiring of OBM Operator and Contingent Labour on need basis for Hydrographic Survey activities & other Miscellaneous activities of IWAI in the stretch of Mahendrapur-Patna- Majhua stretch (NW-1) for the period of September 2025 to March 2026 - Reg.

Inland Waterways Authority of India (IWAI) invites Sealed Quotations for hiring of OBM operator and contingent labour on need basis for conducting Detail Hydrographic survey, Thalweg survey, Land survey, RIS station related works and other Miscellaneous activities of IWAI in NW-1, as per Description of work (Bill of Quantity) for the period from September 2025 to March 2026 (7months). Description of work is enclosed as Annex-A.

The terms and conditions are as under: -

1. The contractor must pay to OBM operator and labour minimum wages as fixed by Govt/CLC time to time.
2. The rate should be inclusive of all taxes (GST) and terms of price should be in Indian Rupees (INR). No other claims will be entertained. The GST amount shall be released on submission of its remittance. Only service charge will be quoted by the contractor.
3. The bidder must enclose proof of similar work done for PSU/ Statutory body or any government agency.
4. The firm will required to submit original tax invoice at the time of submission of claim & Payments will be released on submission of bill within 15 days after deduction of statutory dues if any and duly certification by EIC/ concern officials.
5. The quotation must have validity of at least three months.
6. If the services has not completed within the stipulated time LD of 0.5 % per week is to be charged, subjected to maximum 10 % of the work order value.
7. Price bid shall be submitted in the format attached at Annexure-A which should be duly signed and stamped by the service provider and without any deviation/condition.
8. Inland Waterways Authority of India (IWAI) reserves the right to accept or cancel any quotations without assigning any reason or any prior notices.
9. The sealed quotations shall be submitted up to 06.08.2025 before 15:00 hrs at IWAI, Patna & the received quotation will be opened at Patna on dtd 06.08.2025 at 15:30 hrs.
10. The service provider shall submit a copy of GST registration certificate, PAN card, Bank Account detail/Cancelled Cheque. Quotation received after last date will not be entertained. Claim for loss of life due to accident or otherwise either natural calamities or other reasons what so ever shall not be entrained by IWAI.
11. On receiving of the work order, the agency have to submit security deposit of 10% value of awarded work in favour of IWAI FUND, A/c no: 0352105000002, IFSC Code- CNRB00052 and attend the office at Patna along with two non judicial stamp paper of Rs.100/- (Rs. one hundred only) each to enter into formal agreement and intergrity agreement within 15 days from the date of issue of work order.
12. The supply order may be extended after expiry of work order subject to mutual agreed by firm on same rate terms & conditions.
